What can I include in my project?

Possible projects may include, but are not limited to:

- Roof Repair
- Windows
- Siding
- Electrical
- Furnace
- Water Heater
- Handicap Accessibility

*We can only fund projects that will retain and improve the structural integrity of the property.

- Matching funds will be collected and held in escrow by the Trust Fund before project begins.
- Sufficient financial documentation for households will be obtained each year to verify the units' household median family income.

Mission

To ensure that residents in the Northeast Iowa Counties of Allamakee, Clayton, Fayette, Howard and Winneshiek have access to well-maintained, safe and affordable housing in both the rural and urban areas of each county.



- We are able to fund up to \$12,500 per project with a 3% interest rate loan for a 5 year loan term.
- During the duration of the loan, if the ownership conditions change, the loan will have to be paid.

Requirements

- All units must be rented to households with income less than or equal to 80% of the statewide median family income.
- All units must rent at or below the county fair market rents through the life of the loan, or 5 years, whichever is more.
- Obtain two or more quotes from contractors that are registered with the state, and if built pre 1978, be a Lead Safe Renovator.
- Applicant must provide \$1.00 of private funds for each \$1.00 of program loan.
- Units will need to meet Section 8 Housing Quality Standards upon project completion.
